**SUNDAY – December 8, 2002**

- Location:** Eureka Senior High School. Located just north of Interstate 44, off Highway 109. Take 44 West to Exit 109. Go North (right). Eureka High School will be located on the west side (left side).
- Time:** Sunday, December 8th, 2002. Warm-ups 12:00pm, Meet 12:30 pm.
- Eligibility:** Persons nineteen (19) years old and older are welcome. Participants must have a USMS registration number or completed application to participate. USMS application forms will be available at the meet. All levels of swimming ability are welcome.
- Conduct:** The 2002 USMS rules will govern the conduct of the meet. All events will be timed finals. Events will be seeded by time. Participants will be limited to **FIVE EVENTS**, excluding relays. Relays will be deck entered. Results will be submitted for top ten consideration.
- Fees:** Fee is \$15.00 for all Masters Members. Please make checks payable to St. Louis Masters Swimming. DO NOT SEND CASH.
- Entry Date:** In order to be seeded in proper heats, entries must be received by December 4th, 2002. Deck entries will be accepted, **when lanes are available**. Mail entries to **Lauren Smith, 329 Belt #6A, St. Louis, MO 63112**.
- Facility:** The pool is a 6 lane, 25-meter pool equipped with non-turbulent lane lines. If possible, five lanes will be used for competition, with one outside lane available for swim down.
